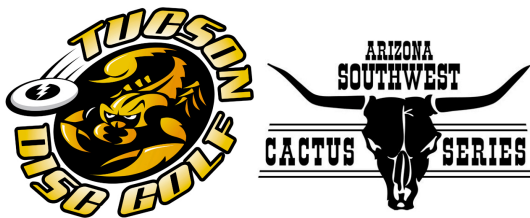


Southern Arizona Disc Golf Classic
